## 2020 Antlerless License Issuing Schedule

**June 22, 2020** – Monday, June 22, 2020. 2020/2021 General Hunting/Furtaker Licenses go on sale!

**July 13, 2020** – Second Monday in July - Landowner sales end. PA Residents may apply for **ONE** license **BY MAIL ONLY!**

**July 20, 2020** - Third Monday in July – **NON-RESIDENTS** may apply for ONE license **BY MAIL ONLY!**

**August 3, 2020**- First Monday in August – First round unsold-may apply for ONE additional license in any WMU **BY MAIL ONLY. WMU 2B, 5C & 5D (SPECIAL REGULATION WMU'S) UNLIMITED BY MAIL ONLY!**

**August 17, 2020** - Third Monday in August - Second round unsold – may apply for a **COMBINED TOTAL** of 3 licenses in any non-special regulations WMU's **BY MAIL ONLY!**

**August 24, 2020**- Fourth Monday in August – **OVER THE COUNTER SALES** begin for WMU 2B, 5C & 5D **ONLY.**

**October 5, 2020** – First Monday in October – Over the counter sales begin **STATEWIDE!**

\*\*\* FIREARMS DEER SEASON TO OPEN ON SATURDAY, NOVEMBER 28, 2020!!!\*\*\*

- *For the second year in a row, opening day of the firearms deer season will be the SATURDAY after Thanksgiving!! This is the FIRST year EVER that SUNDAY Hunting is permitted!! Keeping the opening day as Saturday and including Sunday will create an expanded 15 day season which includes 3 Saturdays!*
- *Fluorescent orange requirements*

- *2020/2021 Pennsylvania Hunting & Trapping Digest will continue be given FREE to ALL license buyers!!*
- *2020/2021 Elk Lottery Drawing – 2 Additional Elk Seasons and Lotteries Approved*

- *NEW DMAP Personal limit: Board of Commissioners expanded the personal limit for certain DMAP Units. Those units will allow for 4 permits per person. Please refer to the Game Commission website for further information*
- *Pheasant Permit REQUIRED for:*
  - *Junior (Resident/Non-Resident) – No Fee Permit offered thru PGC issuing agents*
  - *Adult –(Resident/Non-Resident)*
  - *Senior (Annual License Holders)*
- *EXEMPT From Pheasant Permit:*
  - *Senior Lifetime Hunting/Combination Holders who purchased license prior to May 13, 2017*
  - *Original date of purchase for Lifetime License holders can be found on the 2<sup>nd</sup> license panel.*
- *Remember to RENEW YOUR HUNTING BACKTAG PRIVILEGES BEFORE applying for Doe(s)*
  - *This includes Senior Lifetime Holders*
